Program:

The date the court order is signed by the judge/referee.

ADOPTEE

Program:
Adoption Services

A child who is to be adopted or who has been adopted.

ADOPTION CODE

Chapter X of The Michigan Compiled laws, 1939 PA 288, MCL 710.21 to 710.70.

**ADOPTIVE
PLACEMENT**

Program:
Adoption Services

Placement of a child with an approved family as ordered by a court through issuance of a PCA 320 - Order Placing Child After Consent.

**AGENCY
PLACEMENT**

Program:
Adoption Services

A placement in which a licensed private child placing agency, Department of Human Services, or a court selects the adoptive parent for the child and transfers physical custody of the child to the prospective adoptive parent.

APPROVED FAMILY

Program:
Adoption Services

A prospective adoptive family with an approved adoptive family assessment who has been found suitable for adoption by a licensed private child placing agency, DHS, or comparable agency in another state or country.

BEST INTERESTS OF THE CHILD

Program:
Adoption Services

[MCL 710.22(g)] The sum total of the following factors to be considered, evaluated, and determined by the court when granting consent to an adoption, including:

- a. The love, affection and other emotional ties existing between the adopting individual or individuals and the adoptee.
- b. The capacity and disposition of the adopting individual or individuals to educate and create an environment that fosters the religion, racial identity and culture of the adoptee.
- c. The capacity and disposition of the adopting individual or individuals to provide the adoptee with food, clothing, education, permanence, medical care, or other remedial care recognized and permitted under the laws of this state in place of medical care, and other material needs.
- d. The length of time the adoptee has lived in a stable, satisfactory environment and the desirability of maintaining continuity.
- e. The permanence as a family unit of the proposed adoptive home.
- f. The moral fitness of the adopting individual or individuals.
- g. The mental and physical health of the adopting individual or individuals.
- h. The home, school and community record of the adoptee.

- i. The reasonable preference of the adoptee, if the adoptee is 14 years of age or more and if the court considers the adoptee to be of sufficient age to express a preference.
- j. The ability and willingness of the adopting individual or individuals to adopt the adoptee's siblings.
- k. Any other factor considered by the court to be relevant to a particular adoption proceeding.

CERTIFICATION

Program:
Adoption Subsidy

A determination by the Department of Human Services (DHS) Adoption Subsidy Program that an adoptee is eligible for a support subsidy, nonrecurring adoption expenses, or medical subsidy.

CHILD PLACING AGENCY (CPA)

Program:
Adoption Services

As defined in MCL 722.111 (1) (c): A governmental organization or an agency organized under the nonprofit corporation act, 1982 PA 162, MCL 450.2101 to 450.3192, for the purpose of receiving children for placement in private family homes for foster care or for adoption. The function of a child placing agency may include investigating applicants for adoption and investigating and certifying foster family homes and foster family group homes as provided in the act.

CHILD WITH SPECIAL NEEDS

Program:
Adoption Subsidy

An individual under the age of 18 years for whom the State has determined all of the following:

- The child cannot or should not be returned to the home of the child's parents,

- A specific factor or condition exists with respect to the child so that it is reasonable to conclude that the child cannot be placed with an adoptive parent without an adoption subsidy under this act. The factors or conditions to be considered include ethnic background, age, membership in a minority or sibling group, medical condition, physical, mental or emotional handicap, or length of time the child has been waiting for an adoptive home.
- A reasonable but unsuccessful effort was made to place the adoptee with appropriate adoptive parents without providing an adoption subsidy or a prospective placement is the only placement in the best interest of the child.

COMMITMENT DATE

Program:

The date the judge signs the court order committing a child to DHS.

COMPETING PARTIES

Program:

More than one family interested in adopting a specific child.

CONSENT

Program:
Adoption Services

The granting of permission for an approved applicant to adopt a specific child by the person with legal authority, i.e., the parent, the court for permanent court wards, or the MCI Superintendent for state wards.

CONSIDERATION

Program:
Adoption Services

The process by which the child's adoption worker will explore a specific child's relationship with relatives and other families who have a history with the child and/or a relationship that was significant to the child for purpose of adoption.

COURT

Family Division of the Circuit Court in Michigan.

DEPARTMENT

Michigan Department of Human Services (DHS), formerly Family Independence Agency (FIA).

DETERMINATION OF CARE

Program:
Adoption Services

A Determination of Care is a supplement that may be justified when extraordinary care or expense is required of the foster parents or relative care provider who is eligible for a foster care payment. (See *CFR 903-3*)

DIRECT CONSENT

Program:
Adoption Services

The direct consent is the consent granted to a particular family by the birth parent(s) to accompany a family's petition for adoption. DHS does not process direct consent adoptions.

DIRECT PLACEMENT

Program:
Adoption Services

A private adoptive placement arrangement in which a parent or guardian selects an adoptive parent for a child, other than a stepparent or an individual related to the child within the fifth degree by marriage, blood, or adoption, and transfers physical custody of the child to the prospective adoptive parent.

DISRUPTION

Adoption Services

The termination of a child's adoptive placement prior to adoption finalization.

**DISSOLVED
ADOPTION**

Program:
Adoption Services

Termination of parental rights of adoptive parents either through involuntary termination of parental rights under the juvenile code or voluntary release.

**FAMILY SUPPORT
SUBSIDY**

Program:
Adoption Subsidy

Financial support to families with severely impaired children living at home. A family support subsidy is paid by the Michigan Department of Community Health and is intended to meet the special needs of the family that exceed basic living costs and to prevent institutionalization of the child.

**FINALIZATION
(CONFIRMATION)**

Program:
Adoption Services

The final legal step in the adoption process through which a court confirms that adoptive parent or parents are a child's legal parent(s).

FOSTER CARE

Program:
Adoption Services

24-hour substitute care for children placed away from their parents or guardians and for whom DHS has placement and care responsi-

bility. This includes, but is not limited to, placements supervised by a licensed private child placing agency under contract with DHS, placements in foster family homes, relative homes, group homes, emergency shelters, residential facilities, child care institutions, and preadoptive placements. A child is in foster care regardless of whether the foster care facility is licensed and payments are being made for the care of the child, whether adoption subsidy payments are being made prior to the finalization of an adoption or whether there is federal matching of any payments.

FOSTER CARE PLACEMENT

Program:
Adoption Services

Court-approved removal of a child from the parental home and placement in foster care, a shelter home, a hospital, or with a private treatment agency.

GUARDIAN

Program:
Adoption Services

A person legally appointed by the court to be in charge of a minor child.

HOUSEHOLD MEMBER

Program:
Adoption Services

Any person, other than a foster child, who resides in a foster or adoptive home on an ongoing or recurrent basis (see Licensing Rules for Child Placing Agencies R 400.12101 (k)).

IDENTIFYING INFORMATION

Program:
Adoption Services

Case information that may lead to positive identification of an adopted person. This information may include the names of the birth parents or other birth relatives, the name of child before

placement in adoption, name of each biological parent at the time parental rights were terminated, most recent name and address of each biological parent, and names of the biological siblings at the time parental rights were terminated. [MCL 710.27 (3) (a)(b)(c)(d)]

INTERNET CRIMINAL HISTORY ACCESS TOOL (ICHAT)

Program:

Michigan Criminal History Record Database that is updated daily with Michigan felony and misdemeanor conviction information.

IMMEDIATE CONFIRMATION

Program:
Adoption Services

A motion granted by a court to waive the six-month adoption supervision period that is usually required between the placement of a child in an adoptive home and the finalization of an adoption.

JUDICIAL DETERMINATION

A court determination.

KIN

Program:
Adoption Services

See relative.

**LEGAL RISK
ADOPTION**

Program:
Adoption Services

The placement of a child in an adoptive home during the period that is allowed for a birth parent to request a rehearing or an appeal. The Adoption Code does not permit issuance of an Order of Adoption until all appeals of an order terminating parental rights have been decided.

ENFORCEMENT
INFORMATION
NETWORK (L.E.I.N.)**

Program:
Adoption Services

A database used by law enforcement to gather/maintain pertinent criminal charge and conviction information regarding individuals. DHS child welfare programs have access to information on LEIN through a department agreement with the Michigan State Police. Local office DHS staff cannot do LEIN checks for other government entities, or non-profit agencies contracting with DHS.

**MEDICAL
STATEMENT**

Program:
Adoption Services

A document signed by a physician, physician's assistant or nurse practitioner for members of the household indicating if there are any physical, emotional or mental factors that would jeopardize the physical or mental welfare of any child placed in a family for adoption. A medical statement does not require a physical examination.

MEDICAL SUBSIDY

Program:
Adoption Subsidy

Payment for medical, surgical, hospital and related expenses which are necessary because of a specific physical, mental or emotional

condition of the child which existed, or the cause of which existed, before the adoption petition was filed.

MEPA/IEAP

The Multi-Ethnic Placement Act (MEPA) of 1994 (P.L. 103-382) and subsequent amendments by the Small Business Job Protection Act of 1996 (P.L. 104-188), referred to as the Interethnic Adoption Provisions, prohibit delaying or denying the placement of a child for adoption or foster care on the basis of race, color, or national origin of the adoptive or foster parent, or the child involved (see CFA 700).

NON-IDENTIFYING INFORMATION

Descriptive details about an adopted person and the adopted person's birth relatives that would not lead to positive identification of an adopted person.

NONRECURRING EXPENSES

Program:
Adoption Services

As defined in MCLA 400.115f, reasonable and necessary adoption fees, court costs, attorney fees, and other expenses that are directly related to the legal adoption of a child with special needs. Nonrecurring adoption expenses do not include costs or expenses incurred in violation of state or federal law or that have been reimbursed from other sources or funds.

OFFENDERS TRACKING INFORMATION SYSTEM (OTIS)

The web site that can be used to obtain information about a wide variety of offenders who are under the supervision of the Michigan Department of Corrections.

**OFFICE OF
CHILDREN'S
OMBUDSMAN (OCO)*****Program:*
Adoption Services**

The Children's Ombudsman Act, MCL 722.921, et. seq., created the Office of the Children's Ombudsman (OCO). While this office is located within the Department of Management and Budget, it is an autonomous agency. The purpose of the OCO is to monitor and ensure compliance with relevant statutes, rules and policies pertaining to children's protective services, foster care, juvenile justice, and adoption.

Section 4(2) of the act charges the OCO with the establishment of procedures for receiving and processing complaints, conducting investigations, holding hearings and reporting investigative findings. The Act also requires DHS to provide relevant information as required and cooperate with the Ombudsman in the carrying out of his/her responsibilities (see SRM 132, Response to the Office of Children's Ombudsman).

OTHER EXPENSES***Program:*
Adoption Services**

(Re: Nonrecurring adoption expenses) As defined in MCLA 400.115f, adoption costs incurred by or on behalf of the adoptive parent and for which the adoptive parent carries the ultimate liability for payment, including the family assessment, health and psychological examinations, supervision of the placement before adoption, and transportation and reasonable costs of lodging and food for the child or adoptive parent if necessary to complete the adoption or placement process.

RELATIVES***Program:*
Adoption Services**

As defined in 1939 Act 288, MCL 712A.13a, as amended in December 2004, an individual who is at least 18 years of age related to the child by blood, marriage, or adoption, as grandparent, great-grandparent, great-great grandparent, aunt or uncle, great-

aunt or great-uncle, great-great aunt or great-great uncle, sibling, stepsibling, nephew or niece, first cousin or first cousin once removed, and the spouse of any of the above, even after the marriage has ended by death or divorce. *Related Term:* Kin

**RSDI: RETIREMENT,
SURVIVORS, AND
DISABILITY
INSURANCE**

Program:
Adoption Services

A monthly payment made by the Social Security Administration for retirement, survivors, or disability insurance.

SUPPORT SUBSIDY

Program:
Adoption Services

Payment toward the daily support of an eligible child who has been placed for adoption.

**SSI:
SUPPLEMENTAL
SECURITY INCOME**

Program:
Adoption Services

A cash benefit to a needy, aged, blind, or disabled person. In Michigan, SSI benefits include a basic federal benefit and an additional amount paid with state funds.

Department of Veteran's Affairs.
